

NABIP Texas: Preview of Texas Legislative Session Wrap Up

M Legislation Highlights

Employer & Insurance Reforms

- SB 1332 (Hancock) Senate Bill 51 Fix
 Allows employers to waive late end-of-month termination notices.
 (See extended article in this publication for NABIP-TX's role in passing this bill.)
- HB 138 (Dean) Real Cost Estimates for Health Insurance
 Establishes the Health Insurance Cost and Coverage Analysis Program
 (HICCAP) to estimate fiscal impacts of proposed coverage mandates on employer and family plans.
- SB 926 (Hancock) Physician Shopping Incentives: Tiering & Steering Removes regulatory barriers so plans can offer lower out-of-pocket costs for high-value care.
- HB 1314 (Hickland) Good Faith Estimate Reform
 Allows hospitals to provide estimates based on billed charges and removes protections against unexpected final bill changes.
- SB 331 (Kolkhorst) Expanded Facility Price Transparency Extends machine-readable price transparency rules to:
 - Freestanding ERs
 - Ambulatory surgical centers
 - Urgent care centers
 - Outpatient facilities
- HB 1612 (Frank) Cash Pay Rate Protections
 Ensures uninsured patients can access reduced cash-pay rates, capped at:
 - Lowest average contracted rate + 50%, or

- "Amounts generally billed" + 25%
- SB 493 (Kolkhorst) Prescription Drug Gag Clauses

 Prohibits contract clauses that prevent pharmacists from informing patients about lower-cost alternatives.
- HB 216 (Harris Davila) Itemized Medical Billing
 Requires providers to issue a hard-copy itemized bill upon patient request.
- SB 916 (Zaffirini) Ambulance Surprise Billing Protections Extends surprise billing protections to ground ambulance bills through 2027.
- HB 2254 (Hull) Value-Based Care Expansion
 Expands access to value-based primary care models like direct advanced primary care.
- SB 1330 (Hancock) Medicare & Medigap DME Balance Billing Ban Prohibits out-of-network DME providers from charging Medicare enrollees more than 115% of the Medicare rate.
- SB 1307 (Cook) TDI Biennial Health Coverage Guide
 Requires the Texas Department of Insurance (TDI) to publish a biennial
 "pink book" to help consumers navigate commercial health coverage
 options.

Workforce & Access Expansion

- HB 18 (VanDeaver) Rural Hospital Support
 Provides financial and technical assistance to sustain and expand rural hospitals.
- HB 879 (Frank) Licensing Military Veterans
 Allows physicians, nurses, and PAs licensed in other states and with military service to obtain Texas licenses.

HB 3801 (Orr) – Health Professions Workforce Council
 Establishes a council to develop a biennial strategic plan for strengthening
 Texas's healthcare workforce.

- HB 2038 (Oliverson) Foreign MD Licensure & Non-Resident Practice Creates provisional licenses for foreign-trained physicians and allows supervised practice for graduates without completed residencies.
- HB 4099 (Harris Davila) Physical Therapist Direct Access
 Permits PTs to treat patients without a physician referral for up to 30 days.
- SB 963 (Hughes) MCO Exchange Marketing
 Clarifies that HHSC must allow Managed Care Organizations (MCOs) to market Exchange plan enrollment.

- All-Payor Claims Database (APCD) Funding \$9 Million Allocated
 Supports APCD operations and mandates reporting on:

Annual Convention Exclusive: Peter Nelson, CCIO Director

We're excited to welcome <u>Peter J. Nelson</u>, Deputy Administrator and Director of the <u>Center for Consumer Information and Insurance Oversight (CCIIO)</u>, to the main stage at NABIP's Annual Convention in Miami!

Recap: Agent and Broker Marketplace Meetup in DC

Dr. Oz: "You are mission critical."

NABIP Director of Health Policy & Engagement Nicole LePetri joined Individual Market Working Group Chair Joshua Brooker, Medicare Advisory Group Chair Chalen Jackson, and numerous NABIP members at the 2025 Agent and Broker Marketplace Meetup, hosted by CMS in DC. The event featured sessions with CMS leadership — including CMS Administrator Dr. Mehmet Oz and CMS Deputy Administrator and Director for CCIIO Peter Nelson— and focused on the upcoming Open Enrollment Period, final rule updates, and ICHRA adoption. From Q&A to networking to working sessions, NABIP is proud to be at the table, representing agents and brokers in shaping the future of the Marketplace.

CMS Finalizes Rule on ACA Marketplace Integrity

CMS has finalized the Marketplace Integrity and Affordability rule, implementing several policy changes affecting brokers, agents, and the individual market.

A key provision lowers the evidentiary standard for terminating broker and web-broker participation agreements—from requiring clear and convincing evidence to a "preponderance of the evidence" threshold. NABIP strongly supports addressing the wave of unauthorized plan switching that occurred throughout last OEP and fraud, waste, and abuse in the system. However, NABIP raised significant concerns with this provision, warning that it could lead to more arbitrary enforcement decisions. CMS's own data shows that over 70% of terminations since April 2024 were later overturned, highlighting serious flaws in the current enforcement process and reinforcing NABIP's concerns of unintended disruptions to both consumers and agents.

Another major change allows issuers to require payment of past-due premiums—including those owed to another issuer in the same corporate family—before effectuating new coverage. NABIP supported targeting abuse of guaranteed availability but urged CMS to limit this policy to the same product line (e.g., medical-to-medical) to prevent consumers from losing major health coverage over small balances on ancillary plans like vision or dental.

Other finalized provisions reflect CMS's heightened focus on program integrity. Starting in 2026, a \$5 minimum premium will be required for auto-reenrolled plans to prevent consumers from unknowingly remaining in \$0 premium plans and incurring tax liabilities. CMS also eliminated the monthly special enrollment period (SEP) for individuals under 150% FPL—citing misuse in non-expansion states—and reinstated pre-enrollment verification for 75% of SEP enrollments. While NABIP supported stricter verification standards and a return to a one-year tax reconciliation policy, it flagged concerns that a shortened Open Enrollment window and growing documentation requirements may overwhelm broker capacity. CMS has finalized a November 1—December 15 OEP for 2027 and beyond but has left room for states to adjust to a 9-week period. Many provisions sunset after 2026, as CMS seeks to rebalance the market following the expiration of enhanced tax credits. NABIP will continue to advocate for balanced enforcement, consumer protections, and the vital role of licensed brokers.

State Spotlight: Iowa Employers Push Back on Costly Health Mandate

The Iowa Association of Business and Industry (ABI), along with other plaintiffs including businesses, associations, and labor unions, has filed a federal lawsuit challenging **Senate File 383**, a new Iowa law regulating employer health plans and pharmacy benefit managers (PBMs). The plaintiffs argue that the law:

- Imposes costly mandates that will raise healthcare and pharmacy costs for employers and individuals.
- Conflicts with federal law, specifically ERISA, which governs employer-sponsored health plans and preempts conflicting state laws.
- Threatens business operations, especially due to broad and burdensome regulatory changes.

ABI emphasizes that while the intent to support rural pharmacies is understood, the law's impact is overly broad and harmful. The group is also seeking a **preliminary injunction** to block the law from taking effect on **July 1, 2025**, to avoid irreversible harm to lowans and businesses.

CMS Posts Medicare Commission Schedule for 2026

CMS has published the finalized <u>2026 compensation rates</u> for Medicare Advantage (MA) and Prescription Drug Plans (PDPs). Nationally, MA plans' initial year compensation for MA plans is set at \$694, with renewals at \$347. PDPs are compensated at \$114 for the initial year and \$57 for renewals nationwide. Referral fees are set at \$100 for MA plans and \$25 for PDP plans.
